#### ABOUT THE WORKSHOP

This workshop, presented by a seasoned, certified interpreter and a board certified medical professional, will take participants through two very important aspects of medical interpreting assignments.

First they will break down the interpreting process for various medical appointments from start to finish. Then they will teach participants how to remain safe and avoid infection exposure while working in medical settings. Topics regarding "the process" will include assignment preparation, what to do upon arrival, specific tips, best practice for working in a doctor's office vs. a hospital setting, the art of "giving report" to the next interpreter, HIPAA considerations for interpreters, Universal Codes, and Informed Consent.

Concepts that will be covered, related to "the science" include infectious diseases, PPE (Personal Protection Equipment), contact precautions, droplet precautions, airborne precautions, and interpreting in the operating room including specific instruction on the sterile field, bioterrorism, and suggested vaccinations. This portion will also discuss current updates about COVID-19 precautions.

It will be a day packed full of visuals, activities, lively discussion, and first-hand accounts of many do's and don'ts for interpreters who work in medical environments.

# **OBJECTIVES**

Participants will be able to:

- Outline four ways to approach a medical assignment, based in both clinic or medical centers.
- Develop a systematic approach to researching assignments before and after accepting them
- Analyze and review five key elements of informed consent medical paperwork.
- Develop and implement a plan to give a report to one another with specific emphasis placed on which information is HIPAA compliant and need-to-know.
- Identify four infectious and communicable diseases
- Evaluate four ways to avoid exposure to infectious diseases during various real-life medical assignments
- Organize work-related dangers into three categories with reference to levels of protections, vaccinations, precautions needed for each disease.
- Demonstrate proper technique for performing job duties in a mock operating room situation to avoid the sterile field or contaminating any areas.
