#### WORKSHOP DESCRIPTION

One of the main goals of this workshop is to help interpreters, intervenors, and related DeafBlind support service professionals to become attuned in the area of disability justice through the DeafBlind Lens (the DeafBlind Way) and the Protactile philosophy.
