ABOUT THE WORKSHOP

This workshop, presented by a seasoned, certified interpreter, and a board certified medical professional will focus on medical terminology, the complexity of medical questions, and what to do when an assignment quickly deviates from its original course. During the "mechanics" portion, presenters will put participant's linguistic skills to the test. Participants will be asked to identify the roots, prefixes, and postfixes of commonly used medical terms. Not to worry, they will offer tips for breaking down these compound medical terms into smaller manageable pieces in order to decipher meaning.

Once participants have a handle on vocabulary the presenters will shift gears to help participants begin evaluating questions commonly asked during a medical assessment. They will provide several strategies for identifying the true meaning of these questions, leaving participants armed with tools to accurately interpret them during a medical assignment.

The afternoon portion will focus on "the switcharoo" which deals with the ever-present risk of an assignment taking a sharp, unexpected turn. Presenters will share several options or courses of action interpreters can take when an assignment pulls a "switcharoo", and becomes something other than medical, such as legal or mental health situations. They will even go one step further to identify strategies interpreters can employ when an assignment changes from medical to child services or palliative care. Interpreting in medical settings can be very unpredictable but there are ways to mitigate unfavorable outcomes. Additionally, if interpreters are armed with the right tools they can make better, split second decisions.

It will be a day packed full of visuals, activities, lively discussion, and first-hand accounts of many do's and don'ts for interpreters who work in medical environments.

OBJECTIVES

Participants will be able to:

- Identify the meaning of 15-20 complex medical terms.
- Break down 10-12 compound words commonly seen in medical situations into prefixes and postfixes.
- Analyze the key components of questions posed by medical professionals
- Outline three strategies for providing effective communication of complex medical concepts.
- Demonstrate ability to utilize strategies to interpret questions in a medical setting with various approaches to facilitate communication.
- Formulate a plan to approach an emergency medical/mental health assignment.
- Identify important aspects of palliative and hospice care as they relate to the interpreter's interactions with the patient, family, and members of the medical team
- Recognize the professionals involved in the care of a patient involved with Child and Family Services.
- Restate four responses to multi-layered scenarios that focus on mental health, legal, or other complicated medical situations.
