Between 1997 and 2010 several RID committees drafted seventeen different documents called Standard Practice Papers. These papers are meant to represent the consensus of the RID membership and outline standard practices and positions on various interpreting roles and issues.

We are all familiar with the RID Code of Professional Conduct, but how does it relate to the SPP's? Join us for this series of guided ethical discussions to find out! Prior to each session, participants will be presented with an ethical scenario in a particular discipline within our field. We will engage in lively, respectful conversation about how we flesh out the parts of the Standard Practice Papers that correlate with the CPC.
